### **What's in these website terms and conditions**

These website terms and conditions (**Terms**) tell you the rules for using our website <https://www.safecontractor.com/en-gb/> (our **Site**).

### **Who SafeContractor is and how to contact us**

This website is a Site operated by SafeContractor Limited (**We**). We are registered in England and Wales under company number 07618138 and have our registered office at Axys House, Heol Crochendy, Parc Nantgarw, Cardiff, CF15 7TW.

We are a limited company.

### **By using our Site you accept these Terms**

By using our Site, you confirm that you accept these Terms and that you agree to comply with them. They take effect from the date on which you first use the Site.

If you do not agree to these Terms, you must not use our Site.

### **We may make changes to these Terms**

We may amend these Terms from time to time. Every time you wish to use our Site, please check these Terms to ensure you understand the Terms that apply at that time. These Terms were most recently updated on 30<sup>th</sup> March 2026.

### **We may make changes to our Site**

We may update and change our Site from time to time to reflect changes to our products, our users' needs and our business priorities.

### **We may suspend or withdraw our Site**

Our Site is made available free of charge.

We do not guarantee that our Site, or any content on it, will always be available or be uninterrupted. We may suspend or withdraw or restrict the availability of all or any part of

This clause will not apply insofar as (but only to the extent that) We are unable to exclude or limit text or data mining or web scraping activity by contract under the laws which are applicable to us.

### **Lawful use of our Site**

In the event that any or any part of the terms contained in these Terms shall be determined by any competent authority to be invalid, unlawful or unenforceable to any extent, such term shall to that extent be severed from the remaining Terms which shall continue to be valid and enforceable to the fullest extent permitted by law.
